SALES TAX

The West Sand Lake Fire District is a tax-exempt governmental organization. No tax shall be charged as part of the bid or purchase.

BIDDING ERRORS

West Sand Lake Fire District No 1. will not be liable for any errors in vendor quotes. Vendors will not be permitted to alter bids after the deadline for bid submission.

When, after the opening and tabulation of bids, a bidder claims error, and requests to be relived of award, he will be required to promptly present certified work sheets. The buyer will review the worksheets and if the buyer is convinced, by clear and convincing evidence, that an honest, mathematically excusable error or critical omission of the costs has been made, the bidder may be relieved of his bid.

After opening and reading bids, West Sand Lake Fire District No. 1 will check them for correctness of extensions of the prices per unit and the total price. If a discrepancy exists between the price per unit and the extended amount of any bid item, the price per unit will control. The total of extensions, corrected where necessary, will be used by West Sand Lake Fire District No. 1.

PAYMENT

Payment will be made net 30 upon receipt of a correct invoice for goods that have been delivered and accepted. No Down payment or advance payment of any kind will be made. Board policy requires proof that the materials have been furnished, the services rendered or the labor performed as described before payment will be made. BATTERY OPERATED TOOL BID SPECIFICATIONS:

All submittals must identify any deviations from specifications when submitted proposal. The deviation must be explained and/or described on a separate cover letter when submitted the proposal. Failure to identify deviations must be a basis to declare the bid non-responsive.

GENERAL:

The tool must be cordless, battery operated and self-contained unit capable of withstanding a static over-load pressure of twice the working pressure. This 2:1 over-load ratio is a requirement to provide maximum safety to the operator.

COMPLY: _____ EXCEPTION: _____

The tool must be a “one-person” operated lightweight tool, which means that one person will be able to position, guide and operate the tool without the assistance of other people.

COMPLY: _____ EXCEPTION: _____

The tool must be activated by mans of a rotary Deadman’s handle grip, operated by a twist of the wrist. For ease of operation, the handle shall have a maximum rotation of 20 degrees in either direction. When the Deadman’s handle grip is released, it must return to the neutral position automatically. The Deadman’s handle design will provide one handed ergonomic control of opening and closing functions that does not rely on thumb (single digit) operation. The Deadman’s handle shall provide 360-degree access to the operator allowing operation of the tool in any position. The Deadman’s handle must be located in such a way that it can be operated, guided and supported easily by right and left-handed operators without having to change the position of the hands, even when wearing gloves. The Deadman’s control must be capable of withstanding 6000 endurance cycles, one cycles consisting of opening and closing the tool.

COMPLY: _____ EXCEPTION: _____

All hydraulic rescue tools, parts and accessories will have a lifetime warranty against defects in material and workmanship for as long as owned by the original purchaser.

COMPLY: _____ EXCEPTION: _____

For maximum safety of the operator, only non-toxic mineral based hydraulic fluid should be used. Toxic fluid will not be accepted.

COMPLY: _____ EXCEPTION: _____

Tools must be manufactured in the United States of America

COMPLY: _____ **EXCEPTION:** _____

Hydraulic power must be delivered from an internally mounted pump driven by an internal electric motor that operates on batteries or AC/DC adaptor.

COMPLY: _____ **EXCEPTION:** _____

Power must be provided by lithium-ion batteries, supplied with the tool. The battery must be able to operate in wet weather conditions.

COMPLY: _____ **EXCEPTION:** _____

The battery shall have internal safeguards designed to protect against: short circuit, deep discharge, over and under voltage (battery and cells), Over-current during charging and charging and discharging, Overcharging, over temperature (individual cells and electronics), Charging and discharging outside allowed temperature range. The batteries must be recyclable through a service available in North America. Nickel Cadmium batteries are not acceptable.

COMPLY: _____ **EXCEPTION:** _____

The charger shall provide a 90% charge to the battery in 30 minutes; 100% full charge in 45 minutes for the 3Ah battery; 1 hr for the 5Ah battery. The battery chargers shall be available for 120VAC. The charger shall have a LED lights to indicate the battery state of charge and battery condition.

COMPLY: _____ **EXCEPTION:** _____

The sound level of the tools must not exceed 76 dB(A) measured at a distance of 3.25 feet (1 meter); or 67 dB(A) measured at a distance of 13 feet (4 meters).

COMPLY: _____ **EXCEPTION:** _____

Internal and external aluminum parts of the tool that are susceptible to wear or corrosion must be protected by anodization to provide maximum durability. The tool must be capable of withstanding a 10-day salt spray test, and still be able to function normally.
